INFORMATION CLAUSE

Your personal information data will be processed in order to:

- Execute statutory purposes
- Execute requirements deriving directly from the law, particularly from Legal Act of May the 23rd 1991 regulating Trade Unions (Dz. U. nr 55 poz. 234 ze zm.) and Legal Act of June the 26th 1974 – Labour Code (Nr 24, poz. 141 ze zm.)
- Allow addition of a new member (yourself) to e-mail distribution lists or other electronic communication channels used to exchange information between members and related to statutory actions of our Trade Union “Inicjatywa Pracownicza”¹ which in this document will henceforth be referred to as Trade Union, Union or OZZIP.

Authorised to collect and process personal information data for purposes above are members of Union’s National Committee or presidiums of elemental organisational units of the Union or any OZZIP working on authority of the aforementioned bodies.

OZZIP does not share collective lists of its members with either employer or any other employment entities. However, in the event of an enquiry from the employer or other employment entity for information whether we shall be representing you on your behalf (e.g. in case of a contract termination etc.) we will confirm such representation and will inform you back immediately after using contact details provided in this declaration.

Period in which your personal data will be processed shall begin from the moment of delivery of this declaration (so long as it is properly signed and dated) to our Union’s representative and will continue to be in effect through the period of the time necessary to execute statutory purposes of the Union as well as time period needed by our Administrator to adhere to their responsibilities deriving from rules and regulations of the law.

Consent to process your personal information data including your full name, full name of your employer, details of your contract (including grounds for employment, period of employment to the date in relation to an individual/person performing a paid labour who is not an employee in the meaning of Labour Code) and type of your contract (your working hours) in relation to all people performing paid labour is an obligatory requirement for membership in the Union. Note that retraction of your consent to use your personal information data is equivalent with cancelling your membership with the Union but it does not stop use / processing of your personal information in an extent needed to adhere to the rules and requirements of the law or to protect the Administrator of your details in his duties deriving from said law.

95/46/EC (General Data Protection Regulation)(Dz. Urz. UE L 119 z 04.05.2016, p. 1).

Each member whose personal information data is being used / processed by the union has the right to verify, control, rectification and update, obtaining information on the manner the data is used and stored as well as retraction of their approval to use / process of said data.
